

# City of Americus Information Handbook





### HISTORY OF AMERICUS

Americus' history dates back to 1832 when Sumter County was carved from a portion of Lee County. The area had been an important trading area for the Creek Indians. The Indians had built

several villages along the Aumucculle Creek and Flint River areas. Upon inhabiting the area, the new settlers changed its name from Aumucculle Creek to simply Muckalee.

Sumter County, Georgia was laid off from Lee County by an act of the legislature in 1831, and the following named persons were chosen to lay off the town: John W. Cowart, Green M. Wheeler, Wright Brady and Jackson Tiner. They selected the lot of land No. 156, in the Twenty-seventh district, on the waters of Muckalee Creek and south of Little Creek, now known as Town Creek. The surveyors pitched their tent near where the Central Freight Depot now stands. After laying off the streets and court house square, the commissioners met for the purpose of selecting a name for the county site. Each had a name selected and agreed to put all the names in a hat and blindfolded the writer of this article and let the name that he drew out be the one the town should be named. When Lovett B. Smith, one of the commissioners, told the balance of them that he had selected a name that he thought would suit them all, and Americus was the name, it was agreed upon by all.

### Utility Questions Continued

#### What are utility connection costs for new facilities?

Assuming water and sewer services are readily available, tap fees are as follows:

Water Tap Fee	
5/8" meter	\$465
1" meter	\$640
2" compound commercial variable	\$2575

Sewer Tap Fee (Additionally, a one time connection fee of \$400 is charged)

5/8" meter	\$325
3/4" meter	\$325
2" compound commercial variable	\$1090

### Water & Sewer Department Questions

#### Who do I call when there is a water leak?

Contact the Public Works Department at (229) 924-4411 if the leak is on the City side of the meter. If the leak is on your property contact a plumber.

#### Who do I call when my water is dirty?

Contact the Mill Creek Water Plant at (229) 924-4418 and report the problem.

#### Who do I call when the catch basin is stopped up?

Contact the Public Works Department at (229) 924-4411 and give the location of the catch basin that is stopped up.

#### Who do I call when the sewer line is stopped up?

Contact the Public Works Department at (229) 924-4411 and give the location of the sewer line that is stopped up. After Hours, Call 911.

### Zoning Questions

#### Is my property located in the Historic District?

#### What is a property zoned?

**Utility Questions**

**Does the City offer a budget billing plan?**

Yes, a budget billing plan to residential gas customers is available. For further information, please contact a Customer Service Representative at (229) 924-4411.

**Does the City apply late fees or penalties to utility bills?**

Yes, a 5% penalty is added to past due balances six (6) days after the due date listed on the utility bill.

**If my payment is delayed, what is the normal procedure for disconnecting my utility services?**

The cut off date for the 30th billing cycle will be the second Tuesday of the month. The cut off date for the 15th billing cycle will be the fourth Tuesday of the month. Occasionally, it may be postponed due to unforeseen circumstances. (example: weather, billing problems, etc.)

**My utilities were disconnected for non-payment. When and what time will my services be restored?**

Payment of the past due balance plus reconnect fees must be made in person at our office located on the first floor of the Municipal building. An additional deposit may be required. If payment is received by 3:00 PM, services can be reinstated the same day. Payments after 3:00 PM. are not guaranteed the same day service.

**Do I need to be home when my services are connected?**

Gas service reconnection requires you to be home if you have a pilot light that needs to be lit. Water service can be connected without being home as long as all faucets are in the off position.

**I paid my reconnect fees for water and gas. My water has been turned back on but my gas has not, when will my gas be turned back on?**

The water must be turned on before the gas can be reconnected. If your water has been restored, your gas connection should be reinstated before 5:00 pm on the same day.

**How do I get my utility desposit(s) refunded?**

There are two (2) ways to receive your deposit(s). If your deposit(s) is on file when service is discontinued, it will be applied to your final bill. The city also applies deposit(s) to accounts after two years of good credit history.

## Utility Questions

### **What are the normal business hours of the utility department?**

The Customer Service Center is located at 1404 E. Forsyth Street and is open Monday through Thursday from 8:00 AM to 4:00 PM and Friday from 8:00 AM to 5:00 PM. Representatives can also be reached by phone (229) 924-4411 or by fax (229) 924-4027 Monday through Friday from 8:00 AM to 5:00 PM.

### **How do I apply for residential utility services?**

See a Customer Service Representative at the Customer Service Center located at 1404 E. Forsyth Street. The City of Americus requires a \$75.00 deposit for water service and a \$75.00 deposit for gas service for all residential customers. You must also provide a picture id. A renter must also provide a copy of a lease agreement or rent receipt. The deposits may be waived with a letter of good credit from another utility company showing two (2) years of continuous good standing. New services can be connected the same day providing the application process is completed prior to 3:00 pm.

### **Can my deposit be billed to my account?**

No, the deposits must be paid prior to services being connected.

### **How can I pay my bill?**

You can pay your bill by check, cash, money order, or credit card. Our office also offers bank draft services. For more information, please contact our Customer Service Representative at (229) 924-4411.

### **Where are the City's drop box locations for payments?**

Rubos Grocery on Highway 30, Lee Street entrance of the Municipal Building Parking Lot (101 West Lamar Street), and outside the front of the Customer Service Center (1404 E. Forsyth Street).

### **How are residential sewer charges calculated?**

Residential sewer charges are calculated once every year. The average water usage for the months of February, March, and April are used to calculate sewer charges. The new charge will appear on your May bill.

### **Can I get a discount on my utility bill?**

Yes, a discount is available for senior citizens for gas and water service. To be eligible for this discount you must be 62 years of age or older and the annual household income cannot exceed \$15,600. You may obtain an application by visiting our website at [www.americusga.gov](http://www.americusga.gov) or visiting our customer service center at 1404 E. Forsyth Street.

## Streets & Sidewalk Questions

### To whom do I report a street light that is out?

To report a street light outage call the City at (229) 924-4411 and give the street location or fill out the (Form #95) on our website.

### To whom do I report a missing street sign?

Contact the Public Works Department at (229) 924-4411 with the location of the missing street sign.

### To whom do I report a traffic signal that is not working correctly?

Contact the Public Works Department at (229) 924-4411 with the location of the traffic signal.

### To Whom do I report pot holes in the street?

Contact the Public Works Department at (229) 924-4411 with the location of the repair needed.

### Who do I call to repair my sidewalk?

Contact the Public Works Department at (229) 924-4411 with the location of the repair needed.

### Who do I call to have a tree removed from the city right-of-way?

Contact the Public Works Department at (229) 924-4411 with the location of the tree that needs to be removed.

## Stormwater Questions Continued

### Are churches and other tax-exempt properties required to pay the stormwater user fee?

Yes, all developed properties within the City limits that have impervious areas will be charged a stormwater user fee regardless of ownership or property tax status. All impervious surfaces (e.g. parking lots and rooftops) contribute stormwater runoff, and therefore, all customers would share the implementation cost of the City’s stormwater management program.

### Is there any way to reduce the Stormwater Fee that is being charged?

Both residential and non-residential customers may be able to apply for credits to reduce their stormwater user fee charge by following the procedures that are outlined in the ordinances. The credits will be based on those methods used to directly reduce the impact of stormwater runoff on the City’s drainage system. ### What is the frequency of billing and the billing mechanism?

The stormwater user fee charge will be billed on your existing City of Americus monthly public utility bill. If you do not receive a monthly utility bill from the City, a new account will be set up for you and a stormwater services bill will be delivered to you.

## Stormwater Questions Continued

### Why did the City consider a stormwater user fee charge to fund stormwater management services?

Based on a detailed assessment of the City's current Public Works operation, the City Council has concluded that additional resources are needed to address various drainage system and stormwater management needs in the City. The City Council believes that institution of a stormwater user fee charge, as opposed to a property tax increase, is the most fair, equitable and stable way to fund the future stormwater program. The user fee would not be based on the assessed "value" of a property like a tax; rather it is based on the amount of stormwater runoff that the property generates from its impervious surface. Each customer's stormwater runoff amount results in the City having to provide an adequate drainage system to deal with the water. In general, stormwater services will be provided to customers by the City -- similar to water, sewer, and sanitation services. An additional benefit of a Stormwater Utility is that all stormwater user fee revenues **must** be spent on stormwater and drainage related issues whereas tax revenues are not subject to such restrictions. In contrast, property tax revenues can be spent on any City budget item.

### In the past, how have stormwater services been funded?

In the past, drainage system operation and repair activities have been funded by the annual City budget which is made up of various tax revenue sources. This process has proved to be inadequate and unstable from year to year due to the nature of competing priorities within the City's annual budgeting process and reduced sales tax revenues. The Stormwater Utility was established to fund a more comprehensive stormwater program without drawing additional funding away from other City priorities such as Public Safety.

### Isn't this just another tax?

A stormwater user fee charge is not a tax. Although the stormwater user fee is an additional cost to customers, it is not a tax because it bears little or no relation to the taxable value of a property. If a property is developed and generates stormwater runoff, the customer will be charged a stormwater user fee charge based on the amount of runoff discharged from the property and the stormwater services provided by the City to handle that runoff amount through the City drainage system.

### New Services

To establish any of our utility services, citizens must visit our Customer Service Center located at 1404 E. Forsyth Street during regular business hours. We require original signatures, picture identification, and in the case of rentals, a copy of the rental agreement or rent receipt.

Deposits of \$75 each are required for water and gas residential customers. Residential deposits may be waived if the customer provides a letter of credit from another utility company. After two years of excellent credit, the deposits are credited to the customer's utility account. Commercial customers deposits are based on a monthly average usage calculated by our Customer Service Representatives. If services are discontinued, the deposits are applied to the final bill.

Connections for new facilities will require tap fees for both sewer and water.

### Senior Discount

The Building Risk Management Division directs its efforts toward creating a healthy environment by ensuring that all rehabilitation and new construction meets the minimum building code requirements.

### Building Permits/Inspections

Permits are required before beginning construction or expansion projects. Inspections are done throughout the process. No business license or certificate of occupancy will be issued without a final inspection. All jobs over \$2,500 must be done by a state licensed contractor. Before starting any job, call to see if a permit is required.

### Sign Ordinance

Americus has established standards for the construction and placement of signs within the City. A permit is required before any sign is installed or constructed.

### Fire Marshal

The City of Americus Fire Marshal can help you with any residential or commercial questions concerning fire safety equipment as well as Fire Safety Inspections on Commercial and Industrial property.

### Arson Control

If you have information regarding a fire call [1-800-282-5804](tel:1-800-282-5804). There may be a reward for those who come forward with information that results in the arrest and conviction of arsonists.

## Stormwater Questions Continued

### How do you set a user fee charge for an individual property?

The user fee charge is based on the amount of impervious surfaces on a parcel. Impervious surface means those areas which prevent the natural absorption of rainfall and stormwater runoff. Common impervious surfaces include rooftops, buildings or structures, sidewalks, walkways, patio areas, roads and streets, driveways, parking lots, storage areas and other surfaces such as compacted soil and gravel. The square footage of impervious surface on a property has a direct correlation to the amount of stormwater runoff that flows off that property.

### How would my user fee bill be calculated?

The user fee is based on a billing unit or Equivalent Residential Unit (ERU) that is based on impervious surface. One billing unit (or ERU) will be equal to \$4.00 per month. A stormwater user fee billing unit (or 1 ERU) is the average amount of impervious area on a typical single family property in Americus. Under the current proposal all single family residential properties will be charged a flat rate of \$4.00 per month (or \$48 per year) for stormwater services. All non-residential properties would be charged a custom amount that is based on the total square footage area of impervious surface on their property. For example, if a shopping center has roughly 20 times the amount of impervious surface as a typical residential property, then the shopping center would be charged a monthly stormwater user fee charge that is 20 times larger than the residential charge.

### What if my property has a detention pond?

Customers and properties that operate and maintain a stormwater detention pond might be eligible for a credit (or reduction) against the monthly stormwater user fee charge. Customers should contact the Public Works Department at (229) 924-4411 regarding the available credit application procedures. ### How does this user fee amount compare to other Georgia communities?

The typical user fee rate per ERU for the existing utilities in Georgia is approximately \$3.75 per month.

## Stormwater Questions

### What is Stormwater Runoff?

Stormwater runoff is water that drains off houses, rooftops, driveways, sidewalks, parking lots, roads and other surfaces that do not allow rainfall to soak into the ground when it rains. This stormwater runoff then flows into the City drainage system, and eventually into our streams and creeks including the Flint River.

### How is stormwater runoff a problem?

All developed properties in a community that have manmade surfaces and structures contribute stormwater runoff to the City drainage system, and in some cases, to flooding problems. In addition to potential flooding problems, the stormwater runoff washes chemicals, trash and other pollution into the drainage system and our local creeks. Old and damaged pipe systems have created a need for the City to develop and implement a more comprehensive stormwater management program to address drainage system maintenance issues as well as other high priority projects.

### How does the City intend to deal with these problems?

The City stormwater management program will undertake various activities including the cleaning of ditches, replacement of aging pipes and structures, and the construction of new pipe systems to improve flow.

### How does the City plan to address its multiple drainage needs and priorities?

The Mayor and City Council considered the implementation of a Stormwater Utility and Stormwater User Fee charge to address the City's drainage needs discussed above. All the user fee revenues will be dedicated solely to funding stormwater management and drainage system activities. The Stormwater Utility would service all residences, businesses, institutions and government facilities because all developed properties generate stormwater runoff.

### What is Stormwater Utility?

A Stormwater Utility is an entity whose purpose is to provide services related to stormwater management. Each user (customer) is charged a fee for the service provided.

### What is a Stormwater User Fee?

A Stormwater User Fee is a charge for stormwater management services provided by the City to all residential and non-residential properties in the City. The user fee revenue collected can only be utilized for the provision of stormwater management services.

## CITY GOVERNMENT

The City of Americus is a Georgia Municipal corporation with a seven member City Council composed of the Mayor and six Council members. The Mayor is elected by voters-at-large. The six Council members are elected from single-member districts.

The City is organized under a Council-Administrator form of government. The Mayor and Council are vested with policy making authority. They in turn vest the day-to-day municipal activities to a professional administrator, appointed and removed by the Mayor and Council.

The Mayor and Council meet monthly for the following meetings:

Administrative Briefing—held on the 2nd Monday of each month at 4:30 PM in the meeting room on the third floor of the Municipal Building.

Agenda Setting—held on Thursday following Administrative Briefing at 4:30 PM in the meeting room on the third floor of the Municipal Building.

Council Meeting— held on Thursday following Agenda Setting at 5:00 PM in the Council Chamber of the Russell Thomas, Jr. Public Safety Building.

Meeting dates and times may be changed by vote of the Mayor and Council. All meetings are open to the public. For more information contact the City Clerk at (229) 924-4411.

## CITY GOVERNMENT

### Speaking at a Meeting of Council

If a citizen wishes to speak at a meeting of the Mayor and Council, notification must be given within 72 hours to the office of the City Clerk. A citizen may only speak concerning items that are not on the agenda and may speak for only three

### Sanitation Questions

#### What is my trash and garbage pickup day?

Your garbage and trash days are the same. If you do not know what your pickup day is, call Advanced Disposal at (229) 928-1170.

#### Are appliances picked up?

Yes, appliances are picked up. Contact Advanced Disposal at (229) 928-1170 and schedule a pickup to keep these items from sitting on the street.

#### How do I separate my trash?

Leaves, grass clippings and pine straw must be bagged and placed at the curb in separate piles. Yard waste in a pile, limbs in a pile and metal and plastic in another pile. Limbs 12 inches or less cut no longer than 6 feet. If a limb is 12 inches or more, cut to 2 feet or less (not to exceed 50 pounds).

#### What do I do if my trash/garbage is not picked up?

Call Advanced Disposal at (229) 928-1170 or Utility Billing at (229) 924-4411 and report it.

#### Who do I call if my wheeled container is broken?

Call Customer Service at (229) 924-4411 and ask for a replacement container.

#### How do I report someone that is not following the sanitation rules?

Call the Code Enforcement Officer at (229) 924-4411.

#### Why was my wheeled container given a warning?

The wheeled container must be placed at the curb, no later than 7 AM on the day of pickup. It must be removed in the evening on the day of pickup. Wheeled containers left at the curb can result in a warning and possibly a fine.

### Special Activities Questions

#### Can I rent a park or park facility in Americus?

All parks in Americus are open to the public. However, if you want to use Rylander Park or Rees Park, they can be rented from the City. Please visit our website at [www.americusga.gov](http://www.americusga.gov), and fill out a special activities permit. If you have questions, contact the City Clerk's Office at (229) 924-4411 for more information. The cost to reserve either of these parks is \$50.00.

## Property Tax Questions

### What are the normal business hours of the property tax department?

The Customer Service Center located at 1404 E. Forsyth Street is open Monday through Thursday from 8:00 AM to 4:00 PM and Friday from 8:00 AM to 5:00 PM. Representatives can also be reached by phone (229) 924-4411 or by fax (229) 924-4027 Monday through Friday from 8:00 AM to 5:00 PM.

### When are property taxes billed and when are payments due?

The City of Americus bills property tax twice a year. The first half is billed July 1st and due September 1st. The second half is billed on “or” before October 20th and due December 20th.

### How can I pay my property taxes?

You can pay your taxes at the Customer Service Center at 1404 E. Forsyth Street, Americus, GA. The City accepts cash, checks, money orders and all major credit cards. You can also pay on-line with a credit card. We also offer bank draft services. For more information please contact our office at (229) 924-4411.

### Does the City apply late fees or penalties to taxes?

Yes. A monthly 1% interest charge is added to past due balances. After 60 days, a \$12.00 FIFA charge will be assessed when the City records a lien on the property. Any balance remaining after 90 days past due will have a one time 10% penalty added to the balance.

The Chief Administrative Officer is responsible for implementing policies, programs and laws passed by the City Council; making recommendations for new programs and services; preparing the annual operating and capital budgets and directing and supervising all city departments, properties and operations.

## City Clerk

The City Clerk is the official custodian of the city seal and responsible for maintaining accurate records of all documents of the City of Americus.

### Open Records Request

The City Clerk's office is in compliance with the Georgia Open Records Act. All records are open to the public for inspection upon request.

### Special Activity Permit

Special Activity Permits are required for the use of city owned or operated property. These properties are the Rylander Park and Rees Park. Please contact the City Clerk's office for information.

The Code Enforcement Officer enforces the city's code of ordinances and all state or federal regulations related to solid waste, property issues, recycling and environmental issues.

### Abandoned Vehicle

An abandoned vehicle is a vehicle that is not running, and/or does not have proper insurance or registration. Call the Code Enforcement Office at (229) 924-4411 to report abandoned vehicles.

### Sanitation

The City of Americus contracts for garbage and trash pickup. All household garbage and trash is picked up once per week. The following is a list of rules for collections:

- Household garbage must be bagged before placing in hobo
- Separate piles should be made for bagged yard waste and limbs
- Grass clippings, leaves, pine straw and hedge clippings must be bagged
- Limbs 5 inches or less in diameter cut no longer than 5 feet
- Limbs 6 to 12 inches in diameter cut no longer than 1 foot
- Material such as lumber, shingles, plaster, metal, plastic appliances and furniture in separate pile
- We do not pick up concrete, brick, cement block, dirt or stumps or limbs bigger than 12 inches in diameter
- We do not pick up tires
- We do not pick up contractor debris or demolition debris

### Un-kept Property

The City of Americus has an ordinance that states that property must be maintained in a well-kept condition. Grass and bushes cannot be overgrown, and property must be kept free of debris and trash.

## Police Department Questions

### If I'm going out of town, can the police watch my house?

Yes, you must come to the Police Department at 119 South Lee Street and fill out a security check sheet and give the dates when you will be gone.

### How do I make a complaint on a police officer?

You can contact the Police Department, between the hours of 8:00 AM and 5:00 PM at (229) 924-3677 and ask to speak to the officer's supervisor.

### What are the qualifications for a Police Officer position?

### Where can I get fingerprints taken and how much is the service?

Fingerprinting is done at the Americus Police Department, 119 South Lee Street by appointment ONLY. Call the Police Department Administrative Services Division at (229)924-3677 to make an appointment. There will be no charge if you supply your own fingerprint cards. There is a \$15.00 fee if a fingerprint card must be provided by the police department. There is no charge for non-profit organizations and government agencies.



## Police Department Questions

### How do I obtain a copy of a police report?

All police reports are released in accordance with the Georgia Opens Records Act. Americus Police Reports are available from the police department. Accident reports can only be issued to the person(s) or insurance companies named in the report. If you request a report, only the original occurrence (incident) report and charge sheets can be released until the case has been adjudicated. Basic police reports are usually free and can be obtained by e-mail, fax, or in person.

### How do I find out how much a traffic citation will cost?

You may call (229) 924-3677 and ask for Records. The Records Clerk will be able to advise how much the ticket will cost.

### Where do I go to pay my traffic citation?

All fines are paid at the Americus Police Department, 119 South Lee Street. On the traffic citation, you are given a date that the citation must be paid by. If you do not pay the citation by that day, you must show up for court or your drivers license will be suspended. You may pay your fine by cash, money order or cashiers check. For more information, call (229) 924-3677.

### Can I make an incident report at anytime or do I need an appointment?

Reports can be made at anytime day or night. You must dial 911 anytime you need to speak to an officer. The dispatcher will ask some questions prior to sending a police officer to your home or business.

### Can I make an incident report over the telephone or does an officer have to come to my house?

Some reports can be taken over the telephone. However, it is best if an officer meets with you in order to get all the information needed for the report. Dial 911 and request the dispatcher to send an officer to your location.

### Is there a curfew in Americus?

Yes. City Ordinance requires juveniles under the age of fourteen (14) be home between the hours of 9:00 PM and 6: 00 AM, and juveniles between the ages of fourteen (14) and seventeen (17) years of age be at home between the hours of 12:01 AM and 5:30 AM. If the juvenile is out with a parent or guardian, or coming home from a school function, they must comply with the curfew. If the juvenile is on probation with the Department of Juvenile Justice System, they may have a curfew earlier than 9:00 PM.

### Grant Information

**CDBG (Community Development Block Grant)** The CDBG Program provides funding to assist a wide range of eligible activities, including housing improvement projects, public facilities, buildings and economic development projects. All projects must substantially benefit low and moderate-income persons.

**CHIP (Community HOME Investment Program)** The CHIP program provides funds for rehabilitation and down payment assistance to low and moderate income persons.

The Historic Preservation Commission was established to provide protection, preservation and rehabilitation of historic properties within the historic district. If you plan to renovate, construct a building, place a sign or remove a tree within this district please contact the Community Development Office at (229) 924-4411 for assistance. The Historic Preservation Commission meets the 2nd Thursday of each month at 4:30 PM and the applicant must be present at the meeting.

### Trees on Public Right of Way

The City of Americus has adopted a Tree Ordinance. The City is responsible for trees and shrubs in the City owned parks, along right-of-ways and in other public areas. Please contact the Community Development Department before pruning or cutting a tree that exists in any of these areas.

### What positions are currently available?

## Lot Cleaning Questions

### How do I report property that is overgrown or full of trash?

Call Code Enforcement at (229) 924-4411 and make sure you have a good address or directions to the property so it can be investigated.

### How do I know if the property meets the city standards for un-kept property?

Call Code Enforcement at (229) 924-4411 and the property will be checked. If the property does not meet city standards, the process to get it cleaned will start.

### Do I have to give my name when making reports?

No, you do not need to give your name; however, all information is kept as confidential as possible.

## Natural Gas Department Questions

### Who do I call if I think there is a gas leak?

If you think there is a gas leak, please call Natural Gas Services at (229) 924-7224 between the hours of 8:00 AM and 5:00 PM, Monday through Friday. After hours, contact 911.

## Business License Questions

### What are the normal business hours for the business license department?

The Customer Service Center located at 1404 E. Forsyth Street is open Monday through Thursday from 8:00 AM to 4:00 PM and Friday from 8:00 AM to 5:00 PM. Representatives can also be reached by phone (229) 924-4411 Monday through Friday from 8:00 AM to 5:00 PM.

### Does the City require a business license?

The City does require that all businesses within the City limits maintain a valid business license. For information call the Finance Department at (229) 924-4411.

### How do I renew my business license?

Renewal applications are mailed to all business owners on or before January 15th of each year. If you fail to receive a renewal application by mail, you may obtain one from our website or contact the Finance Department at (229) 924-4411.

### Do I need to have my business license renewed every year?

Yes. Renewals are due on/before March 15th of each year.

### Does the City apply late fees or penalties to business license?

A one time 10% penalty is added for past due balances and a 1.5% interest charge will be added monthly until license is renewed.

### Can I run a business out of my home?

You may be able to run a business out of your home with the proper paperwork. You can print the application from our website and complete it prior to your call/visit. Please visit/contact the Building Risk Management office located on the second floor of the Municipal Building or call (229) 924-4411 to get this process started.

### What do I need to do to start a business in a commercial location in the City?

A Certificate of Occupancy is required for all new and existing businesses located in the city. Businesses that are changing names, changing ownership, or moving to a new location must also obtain a Certificate of Occupancy. This certificate is required before you can legally occupy a building and conduct business operations. The owner MUST contact the Building Risk Management Department to obtain a Certificate of Occupancy (229) 924-4411. You MUST have a Certificate of Occupancy in hand prior to the business license being approved.

### If my business is located outside the City, do I need a business license to do business inside the City limits?

No. The City does not require a business license for businesses located outside the Americus city limits, if they can provide proof that they have a license at another location.

## Zoning and Annexation Information

If you are planning to annex a piece of property into the city or zone/rezone a piece of property already in the city, you are required to submit an application. There is a \$100 application fee and 3 copies of the annexation/zoning plat prepared by a registered surveyor that must be submitted. Prior to annexation or zoning, the Planning and Zoning Commission must review and recommend your request to the City Council. The City is required by state law to advertise and hold a public hearing concerning the recommended annexation or zoning of your property. The Planning and Zoning Commission meets monthly on the 4th Tuesday at 4:00 PM. Please contact the Community Development Department at least 20 days prior to the monthly meeting. The application may be found online at [www.americusga.gov](http://www.americusga.gov).

## Subdivision Developments

If you are planning to develop a subdivision, preliminary plans should be brought to the Community Development Office. These plans will be reviewed by other City officials for their input and comments prior to presentation to the Planning and Zoning Commission. The Planning and Zoning Commission must approve preliminary plans in order for a developer to proceed with construction. The Planning & Zoning Commission meets the 4th Tuesday of every month at 4:00 PM and the applicant must be present for the meeting.

## Alcoholic Beverage License Information

The City regulates the consumption of alcoholic beverages in public places and businesses, and sets selling hours through its local ordinance. The administration and enforcement of this ordinance is handled by our Police Department. However, licenses are issued only through the vote of full Council. The license is valid for only one calendar year and must be renewed annually. The renewal applications are reviewed and voted on by Council each December. Please contact the Finance Department for requirements for both the licensee and the physical establishment.

**An alcoholic beverage license is required any time alcohol is sold by the drink. This applies to events when a ticket for admission is sold and alcohol is served at the event.**

## Budget

The budget process begins in July of each year. The Finance Department compiles information submitted from the Department Heads for a five year capital plan and a one year operating budget and presents it to the Chief Administrative Officer. The CAO makes revisions and recommendations and submits the budget to the Mayor and Council for discussion and final approval. ### Business License Information

In order to operate a business within the city limits of Americus, the operator must have a valid business license. This is obtained by preparing an annual occupational tax return and remitting the appropriate amount of business and occupational taxes. The Finance Department mails renewal tax returns each year on January 15th. The returns are due back to the City by January 31st. Once the City processes the returns, invoices are mailed and the remittance is due by March 15th. Invoices not paid by this date are considered delinquent and are subject to penalties and interest. Please see the FAQ Section on page 58 for more information on business licenses. An application can be found at [www.americusga.gov](http://www.americusga.gov).

### Collection Specialist

The City employs one person who is dedicated to collection activities for all receivable functions. Duties include initiating legal action, holding public sales for non-payment of taxes, door to door visits and collection correspondence. Email [collections@americusga.gov](mailto:collections@americusga.gov) for more information.

### Taxes

Property taxes are billed in two installments with due dates on September 1st and December 20th. Interest is charged at the rate of 1% per month on all delinquent bills. A one time 10% penalty is added to unpaid bills 90 days after the December due date. If the bill remains unpaid, a lien is placed on the property. In April each year, the City publishes a list of all unpaid taxes by property in the Americus Times Recorder. The City then begins legal proceedings, including the sale of property, to satisfy delinquent taxes.

### SIGNS



The Americus Police Department provides law enforcement services for the city. The mission of the Americus Police Department is to identify criminal offenders and criminal activity. They must also reduce the opportunities for the commission of some crimes. The department has the following divisions:

- Administrative Services—This division covers the services of communications, court/police records and training.
- Investigation Division— The Criminal Investigation Division (CID) performs the detailed investigation of crimes in order to prepare the case for prosecution. The purpose of this unit is to conduct follow-up investigations on cases that are not immediately solved by the patrol officer's preliminary investigation.
- Support and Command Services—This division covers services of Municipal Court and Crime Prevention Programs. Programs in crime prevention include home/business burglary prevention, neighborhood watch program, crime avoidance training and other public relations.
- Uniformed Patrol—Field Services Division is responsible for the high profile functions within the department that include traffic enforcement, uniform patrol and crime suppression.

**ANIMAL CONTROL**

The primary emphasis of the animal control office is the enforcement of City Ordinances relating to rabies inoculations and leash laws. The animal control officer is also responsible for addressing problems with non-domesticated animals (i.e. snakes, raccoons, etc.) that are considered a threat or nuisance. 

CH2MHill manages the Water/Sewer Distribution Department privately for the City of Americus. CH2MHill is responsible for the treatment and distribution of potable water and the processing of sanitary sewer for the residents of Americus. This includes the operation of a 7 million gallon-per-day Water Plant and a 4.4 million gallon-per-day Sewage Treatment Facility. The average daily consumption for city residents is 2.5 million gallons per day for water. The average daily treatment of sewer per day for city residents is 2.3 million gallons per day. Ch2MHill is also responsible for ensuring that both operations meet all state and federal guidelines for environmental compliance.

We encourage residents to become involved in the policy making process of City government. More than 70 volunteers serve on the City's 15 advisory boards, authorities and committees. Anyone interested in a board authority or committee appointment should obtain an application form from the Clerk's office, Municipal Building.

**BUDGET (City of Americus)****924-4411**


The City's annual budget is presented to City residents during a public hearing held in November. For more information about the City budget, contact the Chief Administrative Officer.

**BUILDING INSPECTIONS****924-4411**

The City requires inspections for construction, heating, air conditioning, mechanical, electrical and plumbing work. For more information, contact the Building Risk Management Department.

**BUILDING PERMITS****924-4411**

The City requires a building permit for the construction of any new building or the alteration of an existing building. A permit is also required for the installation of signs, swimming pools, garages and other building modifications. For information on building permits, contact the Building Risk Management Department.

## **ADDRESSES (Existing) (229) 924-4411**

To determine the location of property within the City limits contact the Finance Department, Customer Service Center.

## **ADDRESSES (New) (229) 924-4411**

To obtain an address for a new building, contact the Building Risk Management Division, Municipal Building.

## **AIRPORT (Jimmy Carter Regional Airport) (229) 924-2813**

Overseen by the jointly appointed Americus/Sumter County Airport Authority, Jimmy Carter Regional Airport is a full service fixed base operation.

## **ALCOHOLIC BEVERAGES (229) 924-4411**

The City of Americus regulates the consumption of alcoholic beverages in public places and businesses, and sets selling hours for alcoholic beverages. For further information, contact the Finance Department, Customer Service Center.

## **ANIMALS 911**

The Animal Control Officer will remove dead animals from public property. To report a dead animal, call the Police Department. Please forward complaints of injury or cruelty to animals to the Animal Control Officer at the Police Department.

The Animals and Fowl Ordinance requires the vaccination of all dogs and cats against rabies annually. The ordinance includes all areas within the City limits. For more information, call the City Animal Control Officer, Police Department.

## **ANIMALS (Stray) (229) 924-0268**

The sheltering of animals is the responsibility of the Sumter Humane Society, which maintains an animal shelter at 108 Industrial Boulevard.

## **ANNEXATION (229) 924-4411**

If you reside in the unincorporated area of Sumter County and are interested in annexing your property into the City of Americus, contact the Community Development Department, Rees Park Economic Development Center.

## **AUCTIONS (229) 924-4411**

The City periodically auctions surplus city property and unclaimed lost or stolen items. For information contact the Collections Specialist, Customer Service Center.

## **AUTOMOBILES (Accidents) (229) 924-3677**

To obtain information about automobile accidents occurring within the City, contact the Americus Police Department, Records Division.

To report an accident call **911**.

## **AUTOMOBILES (Disabled or Abandoned) (229) 924-4411**

City Code prohibits the parking of disabled automobiles on residential streets. For more information contact the Code Enforcement Officer.

To report an abandoned automobile on the street or on private property, call **(229) 924-4411** and report it to the Code Enforcement Officer.

## **BICYCLES (Registration) (229) 924-3677**

Bicycle registration is not required in the City of Americus, but is provided as a free service for City residents. To register your bicycle, bring it to the Americus Police Department. For more information, call the Police Department.
